Ann Marie Longo called the meeting to order at 6:45 P.M.

Motion by R. Dando, second by J. Romeo, to enter into executive session at 6:45 P.M.to discuss matters of personnel.

Motion by R. Dando, second by J. Romeo, to claim out of executive session at 8:00 P.M.

Representatives from BBS Architects reviewed revised versions of plans for work at the high school, particularly related to the music and art wing which could be funded through the potential bond proposal. They indicated that these revisions were based on discussion and input from the Board. Ann Marie Longo indicated that a committee was formed made up of school personnel, community members, herself, and Jennifer Romeo. She stated that the committee has been reviewing these recommendations and these revised plans were based on input from the committee. BBS reviewed the suggestions and showed 4 different diagrams indicating these suggested changes. After reviewing these diagrams, Ann Marie Longo polled the Board for their opinions on the suggested options. After a lengthy discussion, Ann Marie Longo asked the Board if they were in support of moving forward with a Bond Referendum Proposal. Laura Seinfeld reviewed the timeline for this proposal if the Board wanted to put the proposal out to the community in the fall of 2015. She indicated that ideally the details of this proposal should be presented to the community before the end of the summer. The Board asked BBS to provide them with more detailed drawings based on their input. The Board asked Peter Rufa some questions regarding enrollment numbers in different music and art classes. Mr. Rufa will provide the Board will more detail at the November 18th meeting.

Dr. O'Hara presented to the Board details on the need for a summer program. He spoke on the changes in curriculum, particular in the Math department, and the need for students to continue working over the summer to keep from backsliding. He reviewed a memo that the Board had received in their packet. Dr. Seinfeld stated that there was also discussion on offering summer school to students from other districts to offset costs. Dr. O'Hara reviewed some numbers relative to students who had failed either Regents exams or courses. Dr. O'Hara reviewed summer school enrichment offerings in addition to extra help. The Board discussed the pros and cons of offering a summer program. The Board supported the idea of proceeding with further planning and investigating into the particulars and cost of running a summer program.

Dr. Seinfeld reviewed the purpose of the District Wellness Committee. She asked for a representative from the Board to serve on this committee, indicating that Mr. McEvoy had served as the Board representative

last year. Dr. Castellano will participate this year.

Ann Marie Longo spoke on the NYSSBA Conference that several of the Board members recently attended. Jennifer Romeo and Robin Dando reviewed a presentation they attended entitled "Think Tweets". Dr. Mulhall reviewed her perception of this presentation in relation to Oyster Bay. John McEvoy spoke on a workshop presented by Apple entitled "Freedom From Textbooks".

The Board accepted questions and comments from the community, on agenda items, at this time.
