Ann Marie Longo called the meeting to order at 7:00 P.M.

Dr. Seinfeld introduced Nicholas McKevitt, a student from Roosevelt Elementary School, who led the meeting in the pledge of allegiance. Nicholas was presented with a certificate for his accomplishments and contribution to the Roosevelt school.

Ann Marie Longo called for the approval of minutes from the meetings of January 16th and January 20th, 2015. The minutes were approved.

Maryann Santos reported on correspondence received by the Board.

Dr. Seinfeld introduced Peter Rufa, who spoke on the accomplishments of students who had participated in the All County Music Festival and AGAPAE. They were presented with certificates for this honor.

Valerie Vacchio presented on the Life of a Writer in Oyster Bay-East Norwich CSD. The goals of the presentation were research, Common Core Learning Standards, priorities and next steps, and some highlights. She reviewed the changing expectations relative to the first cohort of students required to pass Common Core Regents Exams, both ELA and math. She stated that the scores indicated students have met the Common Core college and career readiness course-level expectations. She reviewed the next steps and reviewed support for all students which are available in the OBHS library. Ms. Vacchio presented some e-mails received from former students. The Board asked questions relative to the presentation.

Mr. Valente reviewed the Energy Performance Contract. The Board asked questions relative to this conversation.

Mr. Valente gave a presentation on the 2015-2016 budget process. Topics included Board mission and goals, state context, district demographics, preliminary 2014-2015 expenditures, projected 2013-2014 fund balance, and capital planning both short and long term. Mr. Valente gave the projected tax levy limit as of 2/10/2015. He stated the Board had two options, to stay within the estimate levy limit, which is approximately 1.68% or exceed the levy limit. He reviewed the current projected fund balance and some areas where the budget could be reduced if needed. Mr. Valente reviewed current ongoing needs relative to facilities. He spoke on work which was approved under the existing capital reserve in 2006 and amended in 2011 and 2013. Mr. Valente spoke on projects recommended for both a capital reserve proposition for 2015-2015 and a proposed bond and reviewed the bond timelines.

The Board asked questions based on Mr. Valente's presentation. The Board agreed to stay within the tax levy limit. The Board agreed that technology infrastructure should be removed from bond and the bus loop project should be put on hold.

The Board accepted questions and comments from the community, on agenda items, at this time.

E) LIFE INSURANCE CONTRACT/BROWN & BROWN OF NEW YORK, INC. D/B/A FITZHARRIS & COMPANY
