Pre-Bond Community Survey

The Board of Education and administration are seeking community input regarding the future of our school district. The Board of Education and administration have been discussing the possibility of proposing a Capital Project Bond Referendum to support the redesign and expansion of the music and art wing at Oyster Bay High School, which was built in the early 1960's.

This expansion would better accommodate current and future student enrollments, allow for greater flexibility to explore options for additional music and art curriculum and would restore three much needed instructional classrooms to the main building.

Pre-Bond Community Survey

The Capital Project Bond Referendum would support completing the installation of air conditioning in the high school auditorium and possibly installing air conditioning in the high school cafeteria. The plan *may* also include the installation of air conditioning in *one* common area at both James H. Vernon School and Theodore Roosevelt Elementary School.


Pre-Bond Community Survey

The anticipated cost of the proposed Capital Project Bond Referendum would be approximately \$7.2 million. However, the district would be eligible to receive approximately 10 percent in New York State building aid, which would reduce the total cost to community residents.

The cost to the average homeowner would be approximately \$57 a year or approximately \$4.75 a month. Please note that these are estimates at this time and amounts are subject to change given market conditions and future pricing.

Q1 How would you BEST describe yourself? Please choose only ONE.



Q2 How would you BEST describe your awareness of the conditions of our District's facilities?





Q4 Regarding the installation of air conditioning at the high school, please indicate whether or not you believe air conditioning should also be installed in the high school cafeteria.



Q5 Do you agree or disagree that the plan should include the installation of air conditioning in one common area in both James H. Vernon School and Theodore Roosevelt Elementary School?


