Robin Dando called the meeting to order at 7:00 P.M.

Kevin Trentowski presented on Physical Education and Health. Mr. Trentowski reviewed the New York State Learning Standards. He reviewed the Roosevelt Elementary School curriculum and spoke on some special events that were coming up at Roosevelt; Sports Night and Field Day. He reviewed the Vernon curriculum and showed a video which highlighted the experiences of Vernon students in the physical education program.

Mr. Trentowski reviewed the 7-12 physical education program focusing on what students experience at that level. He reviewed the physical education electives that are offered and spoke on the small student to teacher ratio for the adapted physical education program. He also reviewed the health portion of the program. Mr. Trentowski turned the presentation over to Charlie Rizzuto who spoke on the High School health curriculum. He reviewed high school health, exercise science and sports and fitness training Mr. Trentowski ended the presentation with the goal to improve the program.

The Board asked questions relative to Mr. Trentowski's presentation.

Mr. Valente gave the final budget hearing. He reviewed the budget which was adopted April 19th. He reviewed the Board of Education mission and goals, recapped the 2016-2017 budget development process, proposed revenue and expenditure budgets, budget to budget and levy to levy percentages, impact of a failed budget, proposed use of capital reserve funds and important upcoming budget dates.
