R. Dando called the meeting to order at 7:00 pm.

Dr. Seinfeld thanked the BOE for their attendance at the various Board of Education Recognition Week activities. Mr. Cronin and Dr. Ross thanked the staff for the opportunity to see firsthand the wonderful educational environment that is provided for the students.
