J. McEvoy called the meeting to order at 7:00 pm.

Motion by J. McEvoy, second by A. Longo, to enter into Executive Session at 7:01 pm.

Motion by J. McEvoy, second by L. Kowalsky, to claim out of Executive Session at 7:34 pm.

Mr. McEvoy welcomed the community to the meeting and led the community in the Pledge of Allegiance.

Dr. Seinfeld introduced Dr. Mulhall who presented a PowerPoint on Technology Innovation Grants. Dr. Mulhall discussed the formation of the Technology Advisory Committee in the 2013-2014 school year. The goal of this committee is a commitment to advancing our integration of technology to redefine learning and also to learn about best practices in technology integration. Dr. Mulhall introduced Janna Ostroff, K-12 Supervisor Science & Technology for Instruction. Ms. Ostroff discussed three grants that were awarded in the Spring of 2016. These were Makerspace Enhancements, iPads in 12th grade French, and iPads to enhance Genius Hour in 2nd grade. Mr. Agostini and Ms. Patti, Roosevelt second grade teachers presented examples of the work being done in their second grade classrooms. The students are creating Google slide presentations and posting online feeds so parents can see their classroom activities as they happen. Ms. Chiappardi, ENL teacher, discussed the students' growth as readers and writers due to the access to Google classroom. Dr. Mulhall thanked the presenters and stated that the budgetary discussion will continue at the January 23 BOE meeting.

Mr. Cipriani introduced BBS who presented a PowerPoint on the proposed turf field and field house project at Vernon. There was lengthy BOE discussion on infill materials, cost of the field house, new scoreboard, 500 seat grandstand, new fencing, sports lighting and a new pedestrian/access path. Mr. Trentowski, Athletic Director, discussed the benefit of the turf field by various sports teams. BBS will follow-up on what type of infill materials are used at other school districts and various cost options.

Dr. Seinfeld stated that the approved 2017-2018 school calendar built in two snow days so as of now the calendar remains as planned without additional school closings on March 28 and May 24. There was lengthy BOE discussion on the proposed 2018-2019 school year. There was discussion of holidays, snow days and graduation dates.
