J. McEvoy called the meeting to order at 7:00 pm.

Motion by A. Longo, second by R. Dando, to enter into Executive Session at 7:01 pm.

Motion by A. Longo, second by T. Cronin, to claim out of Executive Session at 7:30 pm.

Mrs. Dando introduced Samuel Lingen of Oyster Bay High School who led the community in the Pledge of Allegiance.

Dr. Castellano stated there were two pieces of correspondence received by the Board of Education.

Dr. Seinfeld introduced Mr. Kevin Trentowski, Athletic Director, who recognized the 2017-2018 Winter All County/County Champions in Fencing, Basketball and Wrestling.

Mr. Peter Rufa, K-12 Fine & Performing Arts Supervisor introduced OBHS students who provided a sneak peak of the upcoming musical performance of *Imagine Oz*. The original show dates will be moved due to the forecasted snow storm.

Dr. Mulhall congratulated Jason Hom of OBHS for placing 2nd in his group at the 2018 Al Kalfus LI Math Fair at Hofstra University. There was discussion of how many students take the National Spanish Exam and how OBHS can encourage more students to participate in competitive exams.

F) SEQRA RESOLUTION – OYSTER BAY-EAST NORWICH UNION FREE SCHOOL DISTRICT: PROPOSED CAPITAL PROJECTS

WHEREAS, the Board of Education of the Oyster Bay East Norwich Central School District desires to embark upon the following capital improvement projects:

- Renovations and/or alterations at the James H. Vernon School including replacement of playground surfaces and installation of a Field House;
- Installation of additional ventilation in locker rooms at Oyster Bay High School;
- Theodore Roosevelt School (upgrading of certain bathrooms at Theodore Roosevelt School);
- Replacement of asphalt at Theodore Roosevelt School; and
- Oyster Bay High School: installation of air conditioning in high school auditorium (hereinafter the "Projects").

WHEREAS, the Projects are subject to classification under the State Environmental Quality Review Act (SEQRA); and

WHEREAS, replacement, rehabilitation or reconstruction of a structure or a facility, in kind, in the same site, including upgrading buildings to meet building or fire codes, unless such action meets or exceeds any of the thresholds in section 617.4 are classified as Type II Actions under the current Department of Environmental Conservation SEQRA Regulations (Section 6 NYCRR 617.5 (c) (2)); and

WHEREAS, routine activities of educational institutions, including expansion of existing facilities are classified as Type II Actions under the current Department of Environmental Conservation SEQRA Regulations (Section 6 NYCRR 617.5 (c) (8));

WHEREAS, the SEQRA Regulations declare Type II Actions to be actions that have no significant impact on the environment and require no further review under SEQRA; and

WHEREAS, the Board of Education, as the only involved agency, has examined all information related to the Projects and has determined that the Projects are classified as Type II Actions pursuant to Section 617.5(c) (2) of the SEORA Regulations;

NOW, THEREFORE, BE IT RESOLVED that the Board of Education hereby declares that the above-described capital improvements projects are Type II Actions, which require no further review under SEQRA; and

BE IT FURTHER RESOLVED, that the Board of Education hereby shall forward an official copy of this Resolution to the New York State Education Department together with a copy of the correspondence from the New York State Office of Parks, Recreation and Historic Preservation in connection with its request for approval of the project from the New York State Education Department.

G) RESOLUTION TO AUTHORIZE PROPOSITION TO EXPEND CAPITAL RESERVE FUNDS FOR NEW PROJECTS AND PURCHASES

WHEREAS, the Board of Education of the Oyster Bay-East Norwich Central School District ("Board") has determined that there is a need to undertake certain capital improvements, renovations and/or alterations to District facilities ("Projects") and to purchase and acquire certain equipment, machinery or apparatus necessary for District operations ("Purchases"), to commence during the 2018-2019 school year, as described in the District's Capital Projects Summary ("Report") on file and available for public inspection in the office of the District Clerk; and

WHEREAS, the Board desires that a proposition be presented to the voters of the School District authorizing the expenditure of available funds from the District's Capital Reserve Fund for that purpose, subject to any requisite SEQRA review or determinations prior to the commencement of such Projects or acquisition of such Purchases;

RESOLVED, that the Board hereby authorizes and directs that the following propositions be placed before the voters of the Oyster Bay-East Norwich Central School District at the Annual District Meeting to be held between the hours of 7 a.m. and 9 p.m. on May 15, 2018, at Oyster Bay High School; and that the District Clerk be hereby authorized and directed to give notice of such proposition to be voted at said Annual District Meeting by publishing a notice thereof, four times within the seven (7) weeks next preceding the district election, the first publication to be at least forty-five (45) days before the election, and to have the necessary ballot labels printed for said vote in the form corresponding as nearly as may be with the requirements of the Education Law and the provisions of the voting machine rules of this school district.

PROPOSITION NO. 2 – Capital Reserve Fund Expenditure Proposition

RESOLVED, that the Board of Education of the Oyster Bay-East Norwich School District ("District") is hereby authorized to appropriate and expend from the District's Capital Reserve Fund, heretofore established by the voters of the district on May 16, 2006 and amended on May 17, 2011 and May 21, 2013 and May 16, 2017, an amount not to exceed One Million One Hundred and Thirty Five Dollars (\$1,135,000) to undertake and perform school building improvement projects ("Projects") and to purchase and acquire equipment, machinery or apparatus necessary for district operations ("Purchases"), substantially referred to and described in the District's Capital Projects Summary ("Report") on file and available for public inspection in the office of the District Clerk at no additional cost to district taxpayers; said Projects and Purchases to commence during the 2018-19 school year and to consist of capital improvements, renovations and/or alterations at the James H. Vernon School (replacement of playground surfaces, installation of a Field House), the Oyster Bay High School (additional ventilation in locker rooms), Theodore Roosevelt School (upgrading of certain bathrooms in the building, replacing a portion of asphalt behind the building); all of the foregoing to include furnishings, equipment, machinery, demolition and other work required in connection therewith, as well as preliminary costs and costs incidental thereto and to the financing thereof; provided that the detailed costs of the components of the Projects and Purchases as set forth in the report may be reallocated among such components if the Board of Education shall determine that such reallocation is in the best interests of the district and no material change shall be made in the scope of the Projects and Purchases.

PROPOSTION 3 - Expenditure of Funds for Oyster Bay High School Auditorium Air Conditioning

RESOLVED, that the Board of Education of the Oyster Bay-East Norwich School District ("District") is hereby authorized to appropriate and expend from the District's Capital Reserve Fund, heretofore established by the voters of the district on May 16, 2006 and amended on May

17, 2011 and May 21, 2013 and May 16, 2017, an amount not to exceed (a) \$750,000; and (b) \$150,000 from undesignated unreserved surplus for the purpose of performing the following projects: installation of air conditioning at the Oyster Bay High School Auditorium; all of the foregoing to include all labor, materials, equipment, apparatus and incidental costs related thereto.

H) HEALTH AND WELFARE SERVICES AGREEMENT CONTRACT – NON PUBLIC SCHOOL ATTENDEES

RESOLVED, upon the recommendation of the Superintendent of Schools, the President of the Board of Education of the Oyster Bay – East Norwich Central School District is authorized to sign a Health and Welfare Services agreement with the South Huntington Union Free School District for the purpose of having the South Huntington Union Free School District provide the Health and Welfare services to students residing in Oyster Bay – East Norwich and attending non-public schools located in South Huntington, as per Section 912 of the Education Law, for the 2017-18 school year.

BE IT RESOLVED, that the Board of Education of the Oyster Bay-East Norwich Central School District hereby authorizes the following proposition to be placed on the ballot of the May 15, 2018 annual vote:

PROPOSITION 4 - Establish Capital Reserve Fund known as the Technology Reserve:

RESOLVED, that the Board of Education of the Oyster Bay-East Norwich Central School District ("District"), pursuant to Education Law section 3651, be authorized to establish a Capital Reserve Fund known as the "Technology Reserve" for the purpose of performing the following: (1) security system upgrades and (2) purchase of computer technology equipment and (3) capital improvements as they relate to technology enhancements including, but not improvements/renovations/upgrades, limited electrical improvements/renovations/upgrades, public address/clock system upgrade, sound system upgrades, telephone system upgrades, all of the foregoing to include all labor, materials, equipment, apparatus and incidental costs related thereto. The maximum amount of the aforesaid Capital Reserve Fund shall be \$10,000,000, plus investment income. The probable term is to be 10 years; the funds are to be transferred from surplus monies, if any, remaining in the general fund including a sum not to exceed \$1,000,000 from the 2017-2018 budget and thereafter in an annual amount of not more than \$1,000,000 for each remaining year of the probable term. Upon the establishment and funding of said reserve, the Superintendent of Schools or his/her designee shall be directed to deposit monies of this reserve fund in a separate bank account to be known as the "Technology Reserve."
