Laurie Kowalsky called the meeting to order at 6:30 P.M.

Motion by T. Cronin, second by N. Castrogiovanni to enter executive session at 6:31 P.M.

Motion by D. Gerbosi, second by N. Castrogiovanni to claim out of executive session at 7:32 P.M.

Ms. Kowalsky led the pledge of allegiance and turned the meeting over to Dr. Ianni.

Dr. Ianni began his report by congratulating the Valedictorian and Salutatorian of the Class of 2022. He spoke of Principal appreciation month and congratulated all principals in the district for their hard work and commitment. He also thanked the entire guidance department for their hard work at this busy time of year.

Dr. Ianni spoke on the Capital improvement project vote that will be voted upon tonight which is a critical vote for the district. He encouraged all community members to contact him if there are any questions at all on the upcoming bond vote.

Regarding the agenda for this evening, Dr. Ianni is recommending to the Board to appoint an Assistant Director of Special Services, Nicole Friedman. He then provided an update on Board of Education Goals. In terms of finance, the budget process has begun for 2022/2023. Dr. Ianni invited Ms. Argaman, Guidance Counselor, to the podium and explained AP analysis of 2021 school year during Covid.

Dr. Ianni spoke on college and career readiness. He stated the Board of Education set a specific goal to change the structure of the guidance department, monitor the college application process and acceptance to four-year colleges and expand the use of Naviance to the 6th grade. Ms. Argaman spoke on Naviance,

an on-line tool that helps students develop their college career & readiness. Through age-appropriate assessments, Naviance will help students access their competencies as they think about their college future. All students in grades 6-12 will have access to Naviance. The Naviance link can be accessed through the website under the guidance tab. Dr. Ianni emphasized that Naviance is used by many schools however the main objective is to provide parents with all support tools to empower their children to achieve success.

Ms. Kowalsky discussed moving onto the business/facilities report – update on Bond Vote and SEQRA Resolution. Dr. Ianni stated the SEQRA Resolution was included in his Superintendent's report.

VII Type II 2021 Bond Projects SEQRA Resolution

WHEREAS, the Board of Education of the Oyster Bay-East Norwich Central School District desires to embark upon the following capital improvements at the District's facilities: (1) enhance security system features in the administration building; (2) repair fuel tank high level alarm in the administration building; (3) upgrade interior door hardware in the administration building; (4) renovation of classrooms and music wing in the James H. Vernon School; (5) renovation of music rooms in the James H. Vernon School; (6) renovation of the Butler building; (7) construction of ground storage in the James H. Vernon School; (8) renovation of the cafeteria in the James H. Vernon School; (9) installation of safety glass in the main office of the James H. Vernon School; (10) installation of a natural gas leak detection system in the James H. Vernon School; (11) upgrade the hardware on the interior doors in the James H. Vernon School and the Oyster Bay High School; (12) construction of an innovation lab by the library in Oyster Bay High School; renovation of classrooms in Oyster Bay High School; (13) construction of a turf field at Oyster Bay High School; repair windows at Oyster Bay High School; (14) repair acid waste tank in the boiler room at Oyster Bay High School; (15) repair and replace leaking roof drain lines at Oyster Bay High School; (16) upgrade emergency security and lighting at Oyster Bay High School; (17) insulate internal piping in Oyster Bay High School; (18) upgrade fire command panel at Oyster Bay High School; (19) create areas of rescue on each floor of Oyster Bay High School; and (20) enhance the PA system in the auditorium of Oyster Bay High School (hereinafter the "Projects"); and

WHEREAS, said capital improvements are subject to classification under the State Environmental Quality Review Act (SEQRA); and

WHEREAS maintenance or repair involving no substantial changes in an existing structure or facility are classified as Type II Actions under the current Department of Environmental Conservation SEQR Regulations (Section 6 NYCRR 617.5 (c)(1)); and

WHEREAS, replacement, rehabilitation or reconstruction of a structure or a facility, in kind, on the same site, including upgrading buildings to meet building or fire codes, unless such action meets or exceeds any of the thresholds in section 617.4 are classified as Type II Actions under the current Department of Environmental Conservation SEQR Regulations (Section 6 NYCRR 617.5 (c)(2); and

WHEREAS, routine activities of educational institutions, including expansion of existing facilities by less than 10,000 square feet of gross floor area and school closings, but not changes in use related to such closings (Section 6 NYCRR 617.5(c)(10));

WHEREAS the SEQR Regulations declare Type II Actions to be actions that have no significant impact on the environment and require no further review under SEQR; and

WHEREAS, the Board of Education, as the only involved agency, has examined all information related to the capital improvement projects and has determined that the Projects are classified as Type II Actions pursuant to Section 617.5(c)(1), (2) and (10) of the SEQR Regulations.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Education hereby declares itself lead agency in connection with the requirements of the State Environmental Quality Review Act; and

BE IT FURTHER RESOLVED that the Board of Education hereby declares that the Projects are Type II Actions, which require no further review under SEQR; and

BE IT FURTHER RESOLVED that the Board of Education hereby shall forward an official copy of this Resolution to the New York State Education Department together with a copy of the correspondence from the New York State Office of Parks, Recreation and Historic Preservation in connection with its request for approval of the listed project from the New York State Education Department.

WHEREAS, said "Proposed School District Capital Improvements" are subject to classification and review under the State Environmental Quality Review Act (SEQRA);

WHEREAS, the Board of Education of the Oyster Bay-East Norwich Central School District has designated itself as lead agency pursuant to the implementing regulations of the State Environmental Quality Review Act, specifically 6 NYCRR §617.6(b); and

WHEREAS, the Board of Education of the Oyster Bay-East Norwich Central School District, as lead agency, has caused to be prepared an Environmental Assessment Form (EAF), a Transportation Summary analysis and an expanded environmental assessment report to evaluate potential significant adverse environmental impacts of the proposed action;

WHEREAS, said "Proposed School District Capital Improvements" are classified as an Unlisted Action under SEQRA Regulations; and

WHEREAS, the Board of Education, as the lead agency, has examined the EAF and all information related to the "Proposed School District Capital Improvements" and has determined that the "Proposed School District Capital Improvements" would have no significant adverse impact on the environment.

NOW THEREFORE, BE IT RESOLVED, that the Board of Education of the Herricks Union Free School District, as lead agency for the action contemplated herein, after review of the proposed action, 6 NYCRR Part 617, the EAF and the associated documents, hereby determines that the above-described

project is an Unlisted Action and has no significant adverse impact on the environment which would require further review under SEQRA.

BE IT FURTHER RESOLVED that the Board of Education hereby adopts the annexed Negative Declaration.

BE IT FURTHER RESOLVED that the Board of Education hereby shall forward all necessary information relating to the "Proposed School District Capital Improvements", an official copy of this Resolution and the Negative Declaration to the New York State Office of Parks, Recreation and Historic Preservation for completion of its review contemporaneously with adoption of this Resolution.

State Environmental Quality Review NEGATIVE DECLARATION Notice of Determination of Non-Significance

This notice is issued pursuant to Part 617 of the implementing regulations pertaining to Article 8 (State Environmental Quality Review Act SEQRA) of the Environmental Conservation Law.

The Board of Education of the Oyster Bay-East Norwich Central School District, as lead agency, has determined that the proposed building additional to the Theodore Roosevelt Elementary School as part of the Bond Referendum will not have a significant environmental impact and a Draft Environmental Impact Statement will not be prepared. The overall proposed action was commenced by direct action and constitutes an Unlisted Action under SEQRA.

The action involves a new building addition, interior renovation, and site upgrades; comprising of a ~14,600 gross square feet building addition, replacement of existing heating/cooling systems, install natural gas leak detection system, repair rooftop air conditioning units and create areas of rescue on each floor. The action is proposed to accommodate the projected enrollment increases, allow for better separation of grades and more efficient use of facilities. The project will involve the use of approximately 0.174 acres of maintained grass area within the existing approximately 10.56 acres of school property. Additional investigation into the 0.174 acres of land as well as review of impacts from the project as a whole, have concluded; this project will result in no significant adverse impacts on the environment.

As a result, no further action under SEQRA is required.

RESOLVED BY THE BOARD OF EDUCATION OF THE OYSTER BAY-EAST NORWICH CENTRAL SCHOOL DISTRICT, IN THE COUNTY OF NASSAU, NEW YORK, AS FOLLOWS:

Section 1. furnishings, equipment, machinery, apparatus and ancillary or related site, demolition and other work required in connection therewith, and to expend therefor, including preliminary costs and costs incidental thereto and to the financing thereof, an amount not exceeding the aggregate estimated maximum cost of \$29,971,202; provided that the estimated costs of the components of the Project as set forth in detail in the Plan may be reallocated among such components if the Board of Education shall determine that such reallocation is in the best interests of the District;

- (b) that a tax is hereby voted in the aggregate amount of not to exceed \$29,971,202 to finance such cost, such tax to be levied and collected in installments in such years and in such amounts as shall be determined by said Board of Education; and
- (c) that in anticipation of said tax, bonds of the District are hereby authorized to be issued in the aggregate principal amount of not to exceed \$29,971,202 and a tax is hereby voted to pay the interest on said bonds as the same shall become due and payable.

The voting will be conducted by ballot as provided in the Education Law and the polls will remain open from 7:00 o'clock A.M. to 9:00 o'clock P.M. (Prevailing Time) and as much longer as may be necessary to enable the voters then present to cast their ballots.

AND FURTHER NOTICE IS GIVEN that the registration of the qualified voters of this District for said Special District Meeting is permitted in the District Clerk's Office, located in the Administration Building, 1 McCouns Lane, Oyster Bay, New York, during the hours of 8:00 o'clock A.M. and 12:00 o'clock Noon and from 1:00 o'clock P.M. to 4:00 o'clock P.M. (Prevailing Time), Monday through Friday, up to and including Thursday, December 2, 2021, at which times any person will be entitled to have his or her name placed on such Register, provided that he or she is known or proven to be then or thereafter entitled to vote at such Special District Meeting for which the register is prepared. Registration shall also take place at the James H. Vernon School, 880 Oyster Bay Road, East Norwich, New York, and the Theodore Roosevelt School, 150 West Main Street, Oyster Bay, New York, between the hours of 8:00 o'clock A.M. and 12:00 o'clock Noon and from 1:00 o'clock P.M. to 4:00 o'clock P.M. (Prevailing Time), Monday through Friday, up to and including Thursday, December 2, 2021. A register will be prepared and will be filed in the District Clerk's Office and such register will be open for inspection by any qualified voter between the hours of 8:00 o'clock A.M. and 4:00 o'clock P.M. (Prevailing Time) on each of the five days prior to the day set for the election, except Sunday, by appointment only on Saturday, December 4, 2021; and at the polling place on the day set for said Special District Meeting.

PLEASE TAKE FURTHER NOTICE that the register shall include: (1) all qualified voters of the District who shall personally present themselves for registration; (2) all previously qualified voters of the District who shall have been previously registered for any annual or special District meeting or election and who shall have voted at any annual or special District meeting or election held or conducted at any time within four calendar years (2017-2021) prior to preparation of the said register; and (3) voters permanently registered with the Board of Elections of the County of Nassau.
